

(LJ) 真航空公告

(山)真航空退改票相關規則公告:

- 1. NO SHOW 之定義:以實際搭乘航班為主,即使完成報到手續但未登機仍視為 NO SHOW。
- 2. 申請退票時扣除罰金後,無論任何艙等,稅款及燃油附加費均可全額退回。(罰金費用若高於票款,則計算至將票款抵用完為止,稅款及燃油仍可全額取回)
- 3. 若客人 NO SHOW 後申請退票,則須同時計收 REFUND 罰金和 NO SHOW 罰金。若於航班起飛先將航班取消而後再辦理退費,則可免收 NO SHOW 罰金。
- 4. 退票期限各艙等均有不同(到期後 30 天內或 15 天內),相關規定請於 GDS 中使用 FQN 查詢規定。機票效期計算方式如下,已使用之機票以首段運輸日起算一年內;未使用之機票以開票日起算一年內。
- 5. 客人須依序使用訂位行程,不得在未使用前段行程的情況下搭乘後續行程。若客人搭乘前段行程後欲申請後段行程退費,則依未使用行程之艙等規定辦理。

GDS 開票後免手續費退票規定如下:

- 1. 訂票後當天 23:59 前退票將不收取退款罰金(韓國當地時間 KST Time)。
- 2. 除了取消行程外必須作業完成退款。
- 3. 如退款後須重新訂位請另起新紀錄,進行新的計價開票,請勿在原紀錄中作業。

	No-Show penalty will be imposed for passengers who either do not cancel the reservation prior to check-in closing time(50 minutes before departure) or do not board the flight after check-in.						
	For a no-show ticket, No-Show Penalty would be applied per direction.						
No-Show Penalty	Refund for a no-show ticket would be collected Refund penalty and No-Show Penalty per direction.						
	If 1st direction is unused(no-show) and return direction is not deleted(no-show), the No-show penalty get doubled.						
Unused TAXes	If the total amount of fee/penalty is larger than fare, unused APO tax and YR tax are refundable.						
	If RFND PENALTY WVR AUTH is given, please input the AUTH No. in WA box and refund the ticket.						
Waiver Auth.	If N/S PNLTY WVR AUTH is given, please input the AUTH No. in RM box (or WA if RM doesn't exist).						
Submission Deadline	The refund request should be submitted within 30 days of ticket expiration date and request thereafter may be declined.

(TAX CODE : TQ)	Reissue Fee will be imposed per Reissue and non-refundable, and is not applied on the day of purchase(KST).						
PAX PTC change	Not Allowed after purchase. The ticket should be refunded and repurchased.						
	Flight changes can only be made if there are seats available at the equivalent or higher fare.						
Reissue	For totally unused ticket, validate fares and taxes(including YR) should be recalculated based on the day of reissue.						
	For partially unused ticket, validate fares and taxes(including YR) should be recalculated based on the day of original issue.						
	After using Cpn1, reissue is possible for the remaining Cpn 2 and direction (In that case, reissue Fee is charged twice).						
	Already paid unused TAXes are non-refundable and new TAXes should be collected.						
Waiver Auth.	If Reissue Fee WVR AUTH is given, please input the AUTH No. in ENDS BOX(FE) and reissue the ticket.						
PAX PTC change	Not Allowed after purchase. The ticket should be refunded and repurchased.						
SPELL CHNG	Allowed only if the name is pronounced the same (No Reissue Fee), if not, the ticket should be refunded and repurchased. Please input 'TKT REISSUED DUE TO SPELL CHNG' in FE(ends box).
